Rules of debate at Report Stage: Members are reminded of the rules of debate at Report Stage as set out in the *Companion to the Standing Orders*:

- **Members may only speak once to an amendment** except the mover of an amendment in reply or where the House has given leave to do so to:
 - a member to explain himself in some material point of speech, no new matter being introduced;
 - the Lord in charge of the bill; and
 - a minister of the Crown.

Only the mover of an amendment speaks after the Minister other than for short questions or where the minister speaks early to assist the House in debate.
