Signing up

Members will need to continue signing up in advance to take part in most items of business, including oral questions. Each party/group will continue to order their own speakers with the Government Whips' Office ordering the smaller groups and non-affiliated Members.

Participants lists for the amending stages of bills

As per the Procedure and Privileges Committee guidance, participants lists are only open for one working day (between 10.00am and 6.00pm two working days before a bill is being considered). Details of when each participants list will be open can be found at the end of this document. The Government Whips' Office will not keep any record of names submitted outside of these times.

Speaking from the Chamber

It will be assumed that Members will continue to take part in proceedings remotely unless they indicate otherwise. To take part from the Chamber Members must indicate their wish to do so before the relevant speakers' list closes. To do this Members should email <u>holgovernmentwhips@parliament.uk</u> copying their own Whips'/Convenor's office. If there are more Members wishing to take part physically than there are spaces in the Chamber, it will be for each individual party/group to determine which of their Members make the final speakers' list.

Withdrawing from speakers' lists

Members are asked to notify the Government Whips' Office before 11.00am the day before a debate or question is due to take place if they wish to withdraw from a speakers' list. This is extremely important for oversubscribed debates as it may allow another Member to take part.
